MODERN SPORTS REGULATIONS

The Federation Française de Sports Automobiles, FFSA (French Motor Sport Federation) has established a standard regulation applicable in all French rallies. The 33rd Rallye Charlemagne Golden Palace has been organised following these conditions. These special rules specify and complete the standard F.F.S.A rules for French and second division rallies. Articles not included in this regulation comply with the articles of the standard regulation.

Recommandations To the Competitors

It is thanks to the understanding of the Mayors of the municipalities crossed by the Rallye Charlemagne – Golden Palace, and the city of Hautmont, that we were able to build this 33rd edition.

However, it is thanks to your sportsmanship and responsible attitude that you will be able to adopt during the recognitions and the race weekend, that the sustainability of this event can be assured. We therefore ask you to respect very scrupulously the rules of traffic and the Highway Code, and to cross the inhabited areas at an adapted speed.

We remind you that the recognitions are limited in number of days of recognitions and in number of passages; they are tolerated only from the weekend before the rally and the time slots defined. Apart from these, any recognition is prohibited.

Checks will be carried out jointly by the Gendarmerie, the Police and by us. **No tolerance or indulgence will be given to offenders.**

We rely on your understanding, the elegance of your attitude and behavior depends on the future of our event and rallies in general

1.2P. ELIGIBILITY

The 33rd Charlemagne Golden Palace Rally is on the national calendar.

It counts for:

- The French Rally Championship of 2nd division 2024 (coef. 4),
- The 2025 French Rally Cup (coef. 4),
- The Ligue des Hauts de France Championships.
- Challenges of the ASA 59 Hautmont.

1.3P. VERIFICATIONS

Any crew regularly engaged, will be invited to check on Friday, September 27, 2024, and will find its time on the site of ASA 59 (dedicated table). Only racing vehicles will be allowed to enter the verification area.

Any final checks will take place at the Garage de l'avenue Leclercq 59330 Hautmont. The hourly rate of labor is set at 60 € including taxes.

ARTICLE 3P. COMPETITORS AND PILOTS

3.1P. COMMITMENT REQUEST – REGISTRATIONS

3.1.5P. Any competitor who wishes to participate in the Charlemagne Golden Palace Rally must send to the rally secretariat (postmark) the attached commitment request, duly completed, before September 16, 2024 at midnight.

3.1.10P. The number of entries for the 33rd Rallye Charlemagne Golden Palace is set at 160 cars maximum. In the event that the number of entries in the 7th Charlemagne Golden Palace VHC & VHRS rally (20 cars each) would not be reached, the number of entries in the 33rd Charlemagne rally will be increased without however exceeding 200 cars.

3.1.11.1P. The rights of commitment are fixed:

- with the optional advertising of the organizers: 560 € +10 € (geolocation) + 6 € (curators)
- without the optional publicity of the organizers: 1120 € +10 € (geolocation) + 6 € (curators)

Levy of 6 € on each commitment for the Commissioners of the League of Hauts de France. 5% discount on engagement if an ASA-59 licensee on board, and 10% if full crew ASA-59.

3.3.1P Complies with the FFSA standard regulation.

ARTICLE 4P. CARS AND EQUIPMENTS

4.3P. ASSISTANCE

Complies with the FFSA standard regulation.

Assistance vehicle entries will be in the following time slots:

- Friday 27th, September 2024: from 8am (placement by the organisation)

Only one vehicle per crew will be allowed to enter the assistance park, specific stickers must be placed on the windshield.

Only vehicle exits at the end of the stage are allowed, any exit during the stage is final.

NB: A plateau park is organized, its address will be communicated when taking the road book. The organization cannot be held responsible in case of theft or damage.

4.8: GEOLOCALISATION

The implementation of geolocation should be considered as a mandatory security measure in the same way as a harness or other.

For the duration of the rally, cars must be equipped with a tracker that will be given to them at the administrative control before the Rally, against a deposit (in check of 200 €).

They will be activated at the start park exit of the event (by an official)

This deposit will be returned at the return of the tracers, except in the case where the tracer is not returned within the indicated time and it will then be collected 50 € administrative fee.

In case of withdrawal, the tracers must be returned to the P.C. of the rally, or failing that, given to an official of the event.

In case of impossibility, the trackers <u>must be returned by colissimo the day after the event at the latest, to the following address:</u>

The league undertakes to return the deposit, even in case of total or partial destruction of the tracker following an accident during the rally.

No rental is to be expected. Operating costs are borne by the organizer and the league.

Mounting hardware will be provided. After the rally, this plate will not be taken back and can be used for other events.

There is no need to provide a connection, these trackers are self-powered for the duration of the rally.

During the duration of the rally, any competitor surprised by not having his tracker in place will be sanctioned by the college of stewards, a penalty that can go up to exclusion.

ARTICLE 5P. PUBLICITY

Complies with the FFSA standard regulation.

5.2P. Mandatory and optional advertising will be brought to the attention of competitors by an additive of the organization that will be given when taking the roadbook.

ARTICLE 6P. SITES AND INFRASTRUCTURES

6.1P. DESCRIPTION

The 33rd Rallye Charlemagne Golden Palace represents a 383,710 km course.

It is divided into 2 stages and 4 sections.

It has 6 different special events and 12 in total, with a length of 171,130 km.

The special events are:

1ST STAGE, Saturday 27th, September 2024

6.2P. RECOGNITIONS

Complies with the FFSA standard regulation.

6.2.1P

The maximum number of passes allowed by E.S. will be 3.

6.2.2P. Cars

Recognitions can only be made with the vehicle declared on the entry form.

This vehicle will be standard, without rollbar, without tires other than those homologated road and without means of intercommunication.

Stickers, provided by the organization, identified as 'RALLYE CHARLEMAGNE RECONNAISSANCE + serial number', must be affixed to the places defined at the time of delivery of the itinerary book, and this during the entire period of the reconnaissance.

6.2.5P Duration

Recognitions will take place on September 21st, 22nd & 27th, 2024 from 9 am to 6 pm.

Outside these days and times above, any recognition is prohibited.

ARTICLE 7 RALLY PROGRESS

The competitors of the modern rally will start after the VHC and VHRS rally on Saturday 28 September and will start ahead of the VHC and VHRS on Sunday 29 September.

7.3.5.P Complies with the FFSA standard regulation.

7.3.17. Fresh start after retirement

Complies with the FFSA standard regulation.

7.5.16 INTERRUPTION OF A SPECIAL EVENT

The calculation of the fixed times will be proposed by the Race Management at the College des Commissaires Sportifs and may use the exploitable information of the geolocation. If this is not possible, the usual methods will be used.

7.5.17.4P IT IS **MANDATORY** for a competitor abandoning, in ES or in the connecting sectors, to prevent as soon as possible the :

Emergency number to use only during the race to report abandonment or an accident.

7.5.18P COMPETITORS SECURITY

The trackers have a panic button. This button <u>can only be used for a serious medical request, to the exclusion</u> <u>of any other request.</u> By pressing this button, the competitor must be aware that the E.S. will be stopped and that help will be sent immediately.

If this point is not respected, the competitor incurs a penalty up to the request for translation of the person concerned before the disciplinary committee of the FFSA by the Race Director and/ or the College des Commissaires Sportifs. Deposit cheque payable to Genesis Sport

7.5.19P Chicane Any competitor who runs a chicane, for any reason, will be issued a penalty of 10 seconds per violation.

7.5.20P Trial session Complies with the FFSA standard regulation.

A test session, on a secure closed road, will be organized on Friday 27 September, from 1pm to 5pm. Competitors wishing to participate will have to make the request at the time of their commitment, the participation fee is fixed at 40 € per crew and per car.

The crew must be in racing gear. The car will have to display the distinctive stickers of the test session, their locations will be indicated when taking the road book as well as the place of unloading the race cars.

The organizer reserves the right to cancel this session if the number of participants is less than 20, but also to organize a trial session the week before the event.

ARTICLE 8P. COMPLAINT-APPEAL

Challenge Golden Palace : 15 € extra for each class winner with at least 3 starters

This additional award does not apply to the WRC challenge below

Challenge WRC : A specific challenge that will reward the first 3 WRCs in the overall standings.

The female trophy is reserved for 100% female crews

The women's challenge is reserved for mixed teams with a woman in 1st driver

Michel Wilmart Trophy: reward several commissioners on the Charlemagne rally

For the award ceremony:

Prices will be reduced below 100 participants 100 starters = 100% of prices 90 starters = 90% of prices

84 starters = 84% of prices, etc.

The award of prizes shall be in relation to the actual commitment of the competitor (see art. 3.1.11.1P.) Cash prizes will be sent to competitors by post.
